Dear Mr. Robertson,

I am a former listener to your Network Radio Station WWTN. The reason that I no longer listen to WWTN is because of the deliberate misinformation that was broadcast. If a friend had not informed me of being ridiculed when he decided to provide "on the air" information to your staff and listeners, I would not be writing this letter.

For sometime, Mr. Mike Cornell (202-576-2090 (Work)), a coworker, and I had provided your station with published information on several topics. The information was not only mailed, some was delivered by Mr. Cornell. One of the topics concerned the alleged involvement of the CIA in the S&L crisis. The interview your station conducted with the author of the S&L material was the direct result of our information.

A topic that we provided enormous information on was energy matters. Some of the energy information related to automobiles which achieved more than 100 MPG. Enclosed with this letter are copies of several pages of a book written by Shell Oil Company, they achieved more than 376 MPG in 1973. Also enclosed you will find a page from a U.S. Patent (#4,177,779) for a device that on an American made 1971 V-8 automobile achieved more than 100 MPG.

Yet, despite the fact that your station knew of the above information, they deliberately broadcast misinformation that high MPG automobiles were myths.

The reason for this letter is that Mr. Charles Harris (202-576-0074 (Work)), during a work day last week, called your station between 2 PM and 3 PM. He wanted to provide information that a U.S. Patent had been granted for a device that allows an automobile to burn water. Mr. Harris did not get on the air, what he heard was your announcer say "...a mad man had called to say that cars can burn water...".

A copy of the U.S. Patent, #3,980,053, the "Mad Man", wanted to address is in your hands. I know of several patents of this type.

Mr. Robertson, I can not understand how a former seeker of the nomination for the President of the United States can allow the type of misinformation outlined above to be broadcast. Will you please provide me with an explanation.
